Daycare and/or Boarding Agreement

This agreement is between Dog Boarding of Myrtle Beach and the pet owner whose name is

_____ (full printed name of owner) and whose home address is

_____, _____ and whose signature appears on page 2 (herein called “Owner”).

The following are the terms of service for the stay of the Owner’s pet _____ (Pet Name)

(herein after called “the Pet”) as a boarding or daycare guest of Dog Boarding of Myrtle Beach:

1. By signing this Agreement and leaving the Pet with Dog Boarding of Myrtle Beach, Owner certifies to the accuracy of all information provided to Dog Boarding of Myrtle Beach in writing or orally about the Pet. Dog Boarding of Myrtle Beach takes reasonable precaution and care to ensure the safety and comfort of all pets staying at Dog Boarding of Myrtle Beach. Accordingly, Dog Boarding of Myrtle Beach reserves the right to deny admittance to any pet or to remove any pet for any reason at any time be it for a short time or permanently.
2. Owner specifically represents that he or she is the sole owner of the Pet, free and clear of all liens and encumbrances.
3. Owner specifically represents to Dog Boarding of Myrtle Beach that (a) to the owner’s knowledge the Pet has not been exposed to any contagious diseases within a 30 day period prior to check-in. Owner represents that each time the Pet is brought to Dog Boarding of Myrtle Beach, Owner is recertifying that the Pet is in good health and has not had any communicable illness of any kind for 30 days prior to check-in. And (b) pet is current on necessary vaccinations and is either (1) altered (spayed or neutered), (2) less than 7 months of age, or (3) assumes all risks and costs associated with unaltered/intact pets, and owner agrees to provide Dog Boarding of Myrtle Beach with proof of required vaccinations upon request and prior to check-in. In addition, Owner agrees that if any fleas or ticks are discovered on the Pet during check-in or at any time during the Pet’s stay, Dog Boarding of Myrtle Beach may administer a flea and/or tick treatment, at the owner’s expense, to any pet checking in to the facility. (ex. Bathed with Flea Shampoo and administered Capstar or similar flea control)
4. Dog Boarding of Myrtle Beach agrees to exercise reasonable care for the Pet during its stay and, if applicable, during transport. It is expressly agreed by Owner and Dog Boarding of Myrtle Beach that Dog Boarding of Myrtle Beach’s liability in connection with this agreement shall in no event exceed the lesser of the current chattel value of a Pet of the same breed or the sum of \$200.00 US per animal admitted. Owner releases Dog Boarding of Myrtle Beach from any/all liability that may occur as a result of the Pet jumping over or digging under a fence or enclosure. Owner acknowledges that there is no guarantee and be no exceptions that any personal items left at Dog Boarding of Myrtle Beach will be returned in original condition.
5. Owner agrees to be solely responsible for any and all acts or behavior of the Pet while in the care of Dog Boarding of Myrtle Beach, to include payment of costs for injury to staff, other animals, or damage to the facilities caused by the Pet.

6. Owner understands that Dog Boarding of Myrtle Beach utilizes play groups where dogs interact and comingle. Squirt water bottles may be used for correction and redirection. In extreme cases dogs may be muzzled with soft muzzles for their protection or the protection of other dogs and/or staff members. Owner agrees that the Pet may be removed from a play group at Dog Boarding of Myrtle Beach's sole discretion and not permitted to interact further with other dogs during current or any subsequent stays. Owner further understand that when dogs play in groups nicks and scratches may occur. Staff may or may not notify Owner immediately if the Pet sustains any nicks or scratches. It is the policy of Dog Boarding of Myrtle Beach to attempt to contact and notify the Owner or Emergency Contact if a Pet is seriously injured.
7. In an emergency, Dog Boarding of Myrtle Beach will attempt to contact the Pet's personal veterinarian as well as the emergency contact provided by owner; however, such an emergency may not provide the time to do so prior to the administration of care. Owner authorizes Dog Boarding of Myrtle Beach to obtain medical attention for Pet from any qualified veterinarian and to transport Pet to and from that veterinarian when Dog Boarding of Myrtle Beach deems such medical care is important to Pet's health. Owner grants Dog Boarding of Myrtle Beach or its' employees or agents full power of decision making and power of attorney including the medical treatment of Pet and Owner agrees to pay for all costs. This applies to any claims for injuries or damages related to such medical care or transport. In the event of a Pet's death the Owner or the Emergency Contact will be notified immediately.
8. Any pet left 10 days past designated pick-up date will be considered abandoned and subject to immediate rehoming at the discretion of Dog Boarding of Myrtle Beach. All costs accrued will be the responsibility of the Owner.
9. This Agreement contains the entire agreement between the parties. All terms and conditions of the Agreement shall be binding on the heirs, administrators, personal representatives, and assignees of the Owner and Dog Boarding of Myrtle Beach. If any term of this agreement, in whole or in part, shall be judicially determined to be invalid or unenforceable, such determination shall have no effect on the validity or enforceability of these terms which are otherwise valid and enforceable and this agreement shall remain in full force and effect. Unless necessarily universal in character, any determination of invalidity or unenforceability shall have application only to the extent relevant to the facts and circumstances which give rise to the determination.
